Strengthening the network to ensure better opportunities for young people

Ours is a live network that thrives in the diversity of its members. This variety of organisations, work fields and countries offers a unique environment to shape innovative European social and youth work. To ensure that we make the most out of our exceptional network our aim for 2023 was to strengthen the connections with and among our members.

The first step was listening to them: we carried out a survey to gain input on how could we better support our member organisations. Their insights set the direction for future actions. We kept organising our main events, the Annual Event and the Policy Event, in close collaboration with them. Our Austrian member ÖJAB hosted us in Vienna in June for the Annual Event. Together with our Greek member IEKEP, we held an outstanding Policy Event in Brussels. Thank you both for the fruitful and successful cooperation!







The capacity building of the professionals from our network is essential to improve the employability opportunities of the young people they work with. Member organisations and the professionals working in them have a wealth of valuable expertise from which others can also benefit, and we are exploring new ways to foster this exchange. For instance, some organisations were invited to lead several workshops at the Annual Event to share their knowledge in multiple fields. Participants got familiar with the challenges of intergenerational dialogue at the workplace and discovered the benefits of the Photovoice method by taking part in a short exercise themselves. Mental health on youth and social work was also in the spotlight, as well as experiences on fostering youth participation in Bratislava and transnational cooperation beyond the European Union.

Moreover, our annual Project Planning Meeting evolved into a Project Planning Process. We organised three sessions, two on-site and one online, in which participants shared their project ideas, discussed new working themes and found suitable partners. In order to make these exchanges easier, we are currently working on a members' online platform that will serve as a virtual meeting point.



EU literacy and active citizenship

The YES Forum, in collaboration with its Greek member IEKEP, organised the conference What language does the EU speak? EU Literacy and European Citizenship: Frameworks for Dialogue and Skills Enhancement on November 14-15, 2023, with the aim of enhancing understanding of the European Union, particularly among young people. The conference emphasised the need for inclusive and accessible communication to foster youth engagement in European political processes.

Thais Dutra Fernández, Policy Officer at the European Commission, and Sophie Brandes, Research Officer at the Kompetenzzentrum Jugend-check, initiated discussions on the legislative process, emphasising the challenges of creating youth-friendly legislation. They highlighted the importance of the 'youth check' as a regulatory impact assessment tool to address the concerns and needs of young people.

A youth-led panel from Croatia, France, Germany, Greece, and Italy, showcased their innovative approaches to youth-friendly communication which had been developed during the READY project. Italian Member of the European Parliament (MEP) Salvatore De Meo engaged in a dialogue, providing insights into the impact of such initiatives on young people's inclusion in European political processes.

The second day of the conference focused on materials produced by the READY project and their role in shaping a more social and fairer EU through effective communication. Interactive activities designed by IEKEP tested participants' knowledge of the EU using infographics created by young people and social workers.

Lastly, a panel discussion brought together institutional and grassroots perspectives, featuring Denis Genton, director of the "European Pillar of Social Rights and Strategy" directorate in the European Commission, Anna Holmén, deputy head of communication of the DG Translation in the European Commission, Tommaso Parlatore, advisor to the Director of Campaigns of the DG Communication in the European Parliament, Anna Blackwell, EU Manager in the European Youth Forum, and Dimitra Basiakou, Assistant Project Manager with IEKEP. The session, enriched by the contributions of French MEP Pierre Larrouturou, explored the opportunities and challenges of communication in enabling youth to become active citizens.



We seek to influence policies and practice to create better life opportunities for young people. In 2023 we contributed to the development of policies on social and youth affairs by transferring knowledge gained through practical experience. We will continue to give vulnerable young people and professionals working with them a voice, one that decisionmakers hear and pay attention to.

Advocating for a more inclusive Europe

ADVOCATING FOR A MORE INCLUSIVE EUROPE



Accessible and youth-friendly communication

Young people need to understand the European Union, and for this to become reality, communication needs to be accessible and youth-friendly. To raise awareness on the matter we have undertaken various actions, including producing a policy paper to address the issue of accessible communication, and launching a campaign focused on the gap between youngsters and the EU.

Policy Paper

The Policy Paper – Making the EU language accessible for young people discusses the importance of making EU communication more accessible and understandable, particularly for young people with varying levels of education and language skills. The paper begins by providing general information about EU communication initiatives and then emphasises the significance of effective communication with young audiences. It concludes by offering *p*olicy recommendations to enhance language accessibility when communicating with young people, recognising the need to adapt the EU language to cater to this specific demographic.



Promoting good practices to manage diversity in educational and work environments

Intergenerational knowledge transfer

The YES Forum led, in the frame of the BRIDGE project, the policy brief Bridging the Gap. Based upon the experiences gathered across different trainings and workshops, we developed several recommendations that aim to provide fresh ideas to raise awareness about the impact of demographic change in the workplace. If implemented, our recommendations will improve intergenerational dialogue between

younger and senior workers to create a more inclusive and productive work environment for all.





#explainEU campaign

We shared recommendations and other resources to enhance EU education in our new campaign: Are you really talking to us? *#explainEU*. Alongside useful materials to ensure more accessible communication, the campaign also focuses on young people' and professionals' thoughts on the issue, and makes suggestions on how institutions could be more inclusive.



Inclusive higher education

We compiled good practice on how higher education can be more inclusive to first-generation students. The *Policy* Recommendations on Social Inclusion in *Higher Education* paper, developed during the POWERst project, puts forward several guidelines for best practice. These recommendations advocate for more inclusive approaches and more effective diversity management at schools and universities, addressing students, staff and policymakers.

Initiatives towards ensuring social rights

Position Paper on Inclusive Learning Mobilities May

Within this paper, we provided input to the European Commission's public consultation, in relation to a Council Recommendation proposal on inclusive learning mobilities. Based on our network members' rich experience working with and for young people, our position emphasises the need for comprehensive pedagogical support, increased funding, improved recognition, streamlined processes, and

enhanced collaboration to address obstacles and ensure a successful and inclusive learning mobility experience for young people.



Statement on the EU Youth Strategy August

The EU Youth Strategy is pivotal for fostering a socially inclusive Europe. Our input in the European Commission's mid-term evaluation emphasises the importance of recognising and addressing youth diversity for effective policies. By aligning the strategy with the European Pillar of Social Rights, the EU can

ensure equal opportunities and promote a fairer Europe. We also noted that transparent and updated documentation on implementation is crucial for the strategy's success. person.



Protecting and advancing socio-economic rights lune

Together with Volonteurope we organised the event Civil Society. Protecting and advancing socio-economic rights in Europe in Brussels, bringing in the spotlight civil society's role on protecting and advancing socio-economic rights. The YES Forum and diverse civil society organisations presented their initiatives for ensuring that the European social model prevails.





Civil Society for EU October

We joined a broad coalition of civil society and philanthropy organisations led by Civil Society Europe and Social Platform to advocate for better civic space and civil dialogue all over Europe ahead of the 2024 EU elections.



European Employment & Social Rights Forum

November

We engaged in an inspiring dialogue with diverse European stakeholders on a safe and inclusive transition into AI at work. and about the need to address the current skills shortage in Europe during the European Employment & Social Rights Forum organised in Brussels by the Directorate-General for Employment, Social Affairs and Inclusion of the European Commission. The event gathered EU and national policy-makers, businesses, civil society, and academics.

Erasmus+ programme evaluation December

We did not miss the opportunity to provide our recommendations on improving the Erasmus+ programme. In our position paper we highlighted that

For this reason, we organise workshops, trainings, and webinars to facilitate opportunities for peer-learning and the exchange of inspiring practices. By doing this, we are able to contribute to a more social Europe that invests in the full potential of young people through knowledge exchange.

European Year of Skills

Europe is facing a shortage of qualified workers, which is also impacting the social and education field. To address this gap, the European Union designated 2023 the European Year of Skills to help people gain the right skills for quality jobs.

As life-long learning and education opportunities are at the core of our work, we joined the EYS by organising several expertise exchange workshops for professionals working with young people on:

- Mental health
- International cooperation beyond Europe
- Intergenerational knowledge transfer
- Inclusive youth participation
- The use of Artificial Intelligence in the youth and social field.

These activities reassured us that professionals from our network have outstanding skills and are keen to gain new ones. It proves that our commitment to peer learning and life-long learning initiatives is a key element of our network.

Connecting European and African VET

The SAAM project continued bringing together European and African VET stakeholders in several encounters. In March, more than 60 participants from 24 different African and European countries attended the SAAM Seminar in Brussels on international cooperation. The event gathered VET professionals and European and African policymakers. In November, partners presented the main outputs of this pilot experience in the SAAM Leaders conference in Bilbao.

The YES Forum's work focused on the pre-departure online preparation of African students. The work primarily involved intercultural preparation through dynamic online activities. Based on the experience gained during these sessions, an Intercultural Handbook was edited. This practical manual summarizes the SAAM experience, offering insights for those considering a similar endeavour in the future. It also serves as a resource for reflection on intercultural issues, identity, and strategies to prevent stereotypes and prejudices, even within the confines of one's home.



Fostering participation of young people in municipality processes

In 2023, the focus of the project A part for all remained on empowering the Diverse Youth Action Group in Bratislava. While some members lacked experience in civic engagement, others were already active in student parliaments, scouting, cultural events, and NGOs. Through group discussions and the project's own research, it became evident that young people from diverse backgrounds often encounter barriers to becoming active citizens, such as not knowing where to start or how to communicate with authorities. They perceive a lack of genuine support from adults, feeling that their voices carry little weight. The Diverse Youth Action Group aims to address these issues, dedicating sessions to various forms of participation, finding allies, informal education, crowdfunding, and PR.





Assessing current opportunities and future challenges

Webinar on Artificial Intelligence

Digitalisation and Artificial Intelligence are rapidly changing our work environments and, therefore, our society. A critical approach to new technologies is needed to enhance their positive impacts and avoid the development of new forms of exclusion. Aware of the impact of our work with young people, we recently addressed these issues with our members by hosting an online workshop. Together, we shared our different experiences and examples of how we had implemented AI and digital tools into our everyday life, starting an insightful discussion within the network.

Supporting rural NEETs' employability

The Back on Track Interreg project represents an EU effort to address the pressing issue of rural Germany young people who are out of employment, education and training (NEETs) in the Danube region. The project seeks to understand the characteristics of these young people, provide targeted support, and utilise digital inclusion approaches. It aims to improve their integration into work, employment or training, enhance the attractiveness of rural areas and contribute to the EU's goal of reducing the NEET rate while revitalising rural areas.

Tools to facilitate a more accessible EU education

Education institutions and youth and social work organisations have a crucial role to play in supporting young citizens to better understand and connect with the EU. It is only when young people understand concepts that they can contribute to them.

Based on YES Forum's expertise and our experience of working with young people through our diverse activities and exchange we have compiled a set of guidelines to facilitate a more accessible EU education for organisations working with youth through formal and non-formal outlets.



Raising awareness on the European Green Deal

The UPin project partners have developed youth-friendly content on the European Green Deal. The content simplifies the initiative by using easily understandable language, aligning with youths' communication habits and frequently used platforms. They have developed daily life examples, explanatory videos and an Instagram account. These materials can easily be implemented in educational settings by utilising the project's handbook. All of the results were tested during a training with young people in Palermo (Italy), where participants were familiarised with the Green Deal and produced short videos about the challenges faced by the city regarding pollution and mobility.



Promoting participatory methodologies

Three years of fruitful collaboration in the frame of the VOICE project came to an end. The unique partnership led to a wide array of attractive results to promote the use of the Photovoice method in Europe.

Social and youth workers interested in applying the photovoice method to their work can get invaluable inputs thanks to the materials produced during this journey: a video tutorial, a detailed handbook with ready-to-use supplementary materials, as well as the online exhibitions of the students that participated in the VOICE trainings.

The VOICE experiences and results also served to produce a Policy Brief with recommendations for education and training institutions, organisations and practitioners in the youth and social field and policy-makers to widespread the benefits of the photovoice method.

Moreover, the photovoice method was also introduced to students of the Master Social Policy & GLOBED Program of the University of Bremen as part of the Advanced Research Methods course.











INNOVATIVE LEARNING AND EDUCATIONAL APPROACHES

Empowering political education

In the last few years, we have gained long experience working in the field of political and civic education through innovative and participatory approaches. We explored the opportunities raised by simulation games, promoted participatory research methods and provided documents that are easy to understand. We seek to enhance knowledge of EU institutions and encourage the youth to become active European citizens, involving the youth and social workers who work directly with our target group as well.

The topics of active citizenship, EU awareness, the promotion of social inclusion through more inclusive approaches and nonformal political education will continue to guide our work in the coming years. This is aligned with our strategic aims to generate better prospects for young people and the optimization of professional approaches. The upcoming European Elections in June 2024 offer an invaluable opportunity to share and deepen our expertise in this field.

Accessibility and inclusivity: a remaining challenge

Learning mobility programs serve as a crucial way for young individuals and professionals to gain international experience in Europe, significantly impacting their career growth by expanding their skills and competencies. These initiatives play a pivotal role in fostering personal development within an international context.

Acknowledging mobility as central to the EU's transformative goals, the YES Forum is dedicated to promoting inclusive learning opportunities. We offer high-quality mobility programs for both professionals and disadvantaged youth, aiming to strengthen connections and enhance essential soft skills for improved employability. Through these initiatives, participants build self-esteem, confidence, critical thinking abilities, and a deeper understanding of the European Union, promoting active citizenship.

In our latest report on learning mobilities, we addressed challenges on the accessibility of mobility experiences and provided recommendations based upon our extensive experience of youth work, education, and vocational training. We advocate for the implementation of these recommendations to reshape eligibility criteria and the application process, ensuring that learning mobility opportunities are accessible and genuinely inclusive for disadvantaged youth and professionals. We advocate for the implementation of these recommendations, which would result in the redesign of the existing eligibility criteria and application process to ensure that learning mobility opportunities are made truly inclusive for disadvantaged youth and professionals.

It was inspiring to see how creative contributions as well as in-depth discussions about global and local environmental issues emerged during the UPin training. At the same time, the discussions highlighted the differences in our individual attitudes towards climate change and the Green Deal policies, shaped by our social and cultural backgrounds. It also demonstrated that everyone is united by a common goal and the mission to fight for a better, more sustainable future.

I believe that it is European climate educational projects like this (in conjunction with national education for sustainable development strategies) that are essential to provide young people with a sense of self-efficacy, and which incentivise them to unite and become active in the fight against climate change.



Exchanges within the network

Six students of the VET courses in Zefiro participated in a learning mobility experience at Musikcafé After Eight facilities in Finland to enhance their skills in an innovative educational setting. Moreover, the accompanying staff gained new insights through job shadowing, aiming to identify and implement effective practices at their vocational training centre in Tuscany.

Being in another country and connecting with another culture is an irreplaceable learning experience, from just observing their daily life to exchanging anecdotes and comparing different ways of life. I got very close to the people I met there, we learned about each other and appreciated each other from our differences, which became a point of connection and not something that would make us feel distant.

During my internship, I learned to use all the different printers, 3D, laser, fabric and the old typography printer. I learned various new opensource software and how to create patterns and logos to print with these different tools. On a personal level I had a lot of fun and with time I was satisfied with the new things I learned, in Italy not many people can teach you these kinds of things, so I am very happy to have learned them, I know they can come in handy in the future.

To be honest, I expected a normal trip, but when it ended, I could have not asked for a better experience, it exceeded all my expectations.
